GUIDANCE NOTES FOR PARENTS AND GUARDIANS

ELIGIBILITY FOR ENTITLEMENT

If you are in receipt of any of the following you will be entitled to Free School Meals for you child:

- Income Support
- Income-based Jobseekers Allowance
- An income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (provided they are not entitled to Working Tax Credit) and have an annual income (as assessed by Her Majesty's Revenue and Customs)that as of 6th April 2010 does not exceed £16,190
- The Guarantee element of State Pension Credit
- Note: If you are in receipt of Working Tax Credit during the four-week period immediately after your employment ceases, or after you start to work less than 16 hours per week, your child/children are entitled to free school meals.

CONFIRMATION OF ELIGIBILITY

Your application may be checked using The Department for Children, Schools and Families (DCSF) Free School Meals Eligibility Checking Service and the information you have provided in Part A of this form. The results will be a yes/no confirmation and your child's school will be informed of this.

DOCUMENTARY EVIDENCE

You may be requested by the school to provide documentary proof of entitlement.

CHANGE OF CIRCUMSTANCE

You must inform the school immediately of any change in your benefit entitlement.

Once you have completed the form please return it to YOUR CHILD'S SCHOOL as soon as possible. Free school meals cannot be provided until the school has received the form and verified your eligibility.
